

SOFTWARE LICENSE AGREEMENT

Definitions

- 1.1. "Licensor" refers to SEMIDYNAMICS TECHNOLOGY SERVICES, S.L. located at Muntaner 447 P.4 Pta.1 08021 Barcelona (Spain).
- 1.2. **"Licensee"** refers to the individual or entity that downloads, installs or otherwise uses a copy of the Software.
- 1.3. "Software" refers to the computer programming code, including any updates, patches, or modifications as well as any related data, files and/or electronic and online materials provided by the Licensor.
- 1.4. "Permitted Use" refers to the specific purposes outlined in Section 2.2.

2. License Grant

- 2.1. Subject to compliance with the terms and conditions of this Agreement, the Licensor grants the Licensee a free, revocable, non-exclusive, non-transferable, non-sublicensable license to use the Software solely for the Permitted Use.
- 2.2. Permitted Use: The Licensee may use the Software free of charge. The Software may be downloaded onto no more than one computer. A single copy may be made for backup purposes only.
- 3. **Restrictions:** The Licensee agrees that they will not:
 - Copy, distribute, or reproduce the Software except as expressly permitted by the Licensor in writing.
 - b) Reverse engineer, decompile, disassemble, or attempt to derive the source code of the Software.
 - c) Modify, adapt, or create derivative works based on the Software.
 - d) Use the Software to create competing products or for any purpose that violates applicable laws or regulations.
 - e) Share, rent, lease, or sublicense the Software to any third party or allow any third party to access or use the Software.
 - f) Use the Software for aeronautical, aerospace, military or nuclear applications or for life support or life endangering applications where failure or inaccuracy might cause death or personal injury.

4. User Support

No user support or maintenance is provided as part of this Agreement.

Although technical support may be offered through email and/or website postings, the Licensor makes no quarantee that such support will be available, timely, or accurate.

5. Ownership

The Software is the exclusive property of the Licensor. This Agreement constitutes a license for use only and is not in any way a transfer of ownership rights of the Software. Accordingly, the Licensee acknowledges that no ownership rights in the Software are transferred by this Agreement. All rights not expressly granted to the Licensee are reserved by the Licensor.

6. Confidentiality

The Licensee agrees to maintain the confidentiality of the Software and any related data, files and/or electronic and online materials provided by the Licensor. The Licensee shall not disclose the Software or any portion thereof, or any performance or efficiency metrics inferred by the use of the Software to any third party without the Licensor's prior written consent.

7. Term and Termination

- **7.1. Term**: This Agreement is effective upon download, installation or use of the Software and will continue until terminated by either party.
- **7.2. Termination by Licensor**: The Licensor may terminate this Agreement immediately if the Licensee breaches any terms of this Agreement.
- 7.3. Effect of Termination: Upon termination, the Licensee must cease all use of the Software and destroy all copies in their possession or control. The Licensor may request to provide certification of such destruction.
 - All provisions of this Agreement relating to disclaimers of warranties, limitation of liability, remedies or damages, and Licensor' proprietary rights, shall survive any termination of this Agreement for any reason.

8. Limited Warranty and Disclaimer

8.1. The Software and any related data, files and/or electronic and online materials are provided "AS IS," without any warranties, express or implied, including but not limited to warranties of merchantability, fitness for a particular purpose, or non-infringement.

Likewise, no oral or written information or advice given by Licensor as technical support shall create a warranty.



8.2. The Licensor does not warrant that the Software will meet the Licensee's requirements or that its operation will be uninterrupted or error-free. The Licensee accepts that software in general is prone to bugs and flaws within an acceptable level as determined in the industry.

9. Limitation of Liability

To the fullest extent permitted by applicable law, the Licensor shall not be liable for any direct, indirect, incidental, consequential, or punitive damages arising out of the use or inability to use the Software, even if advised of the possibility of such damages.

10. Miscellaneous

- **10.1. Severability**: If any provision of this Agreement is deemed unenforceable, the remaining provisions shall remain in full force and effect.
- 10.2. Amendments: Any terms of this Agreement may be changed by the Licensor without notice.

11. Governing Law and Jurisdiction

This Agreement shall be governed by and construed in accordance with the laws of Spain. Any disputes arising under or in connection with this Agreement shall be subject to the exclusive jurisdiction of the courts located in Barcelona (Spain).
